

Thank you and we sincerely hope for your favorable response. We look forward to your full support and cooperation for the successful celebration of Nutrition Month in the region.

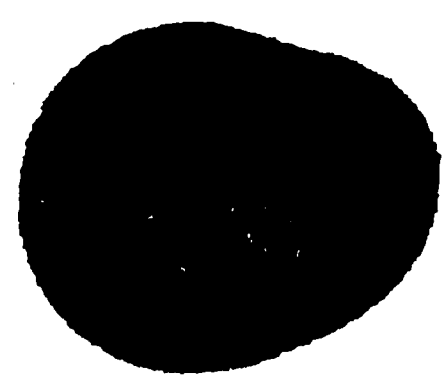
