We noted that despite the issuance of a Memo relative to the re-orientation, training and staff development of Security Personnel and Utility Workers held last Sunday, July 3, 2011, many of those listed in the records submitted to us by the Personnel Section of the Division of City Schools were absent.

Please remind those concerned that attendance in the said activity is a MUST. In this regard, we are transmitting the herein Memoranda directing concerned employees to submit a written explanation on their failure to attend said activity. This further informs that repetition of the same shall be dealt with accordingly.

Based on the Orientation Meeting conducted last Sunday, most of the contractual security enforcers and utility workers have signified their intention to undergo the 30 Saturday trainings conducted by the Philippine Army. In this regard, we are requesting all school principals to allow their contractual security enforcers and utility workers to attend the said training program every Saturday from 8:00a.m. to 5:00p.m. The venue for this month until September 3 shall be at the 14th floor, Quezon City Hall. Venue for the succeeding weeks will be announced later. Said training is vital in the performance of their functions as security enforcers and utility workers.
