

1. Pursuant to Republic Act No. 6759 otherwise known as "An Act Declaring August 1 of Each Year as **White Cane Safety Day** in the Philippines and for Other Purposes", the theme for this year's celebration is "**P.R.O. - White Cane**" (**Promote Recognition Observance of White Cane**).

2. The White Cane Safety Day Celebration is the first activity of the Sight Saving Month Celebration in August. The activity aims to:

- a. stimulate public awareness on the welfare of blind persons;
- b. promote recognition and acceptance of the White Cane as a symbol of mobility for blind persons;
- c. promote and protect the physical, moral and social well-being of blind persons; and
- d. serve as a vehicle of information on the programs being implemented by government and nongovernment organizations that adhere to the promotion of the welfare of visually impaired persons.

3. The Department of Education (DepED) as lead agency of the Inter-Agency Committee for the celebration, has prepared the following activities which will be undertaken on August 1, 2009.

- a. Hanging of Streamers
- b. Motorcade from Quezon City Hall to SM North EDSA (NCR participants);
- c. Distribution of White Canes, Talking Watches to selected blind students; and
- d. Recognition and Awarding (Achievement Awards to Successful Blind Persons).

4. The aforementioned activities can be conducted at the regional level through the initiative of the Regional Special Education Council. Other GOs, NGOs, and civic organizations could be tapped for assistance. All concerned may coordinate with any SM malls in their respective localities for possible venues.

5. Other suggested activities for the celebration include:

- a. Sharing information on best practices concerning the education of the visually impaired by inviting blind students or educators as resource persons and other professionals working for the blind;
- b. Inviting ophthalmologists/optometrists to conduct free eye examination and screening to visually impaired students;

- c. Holding symposia, fora and panel discussions relevant to the prevention and rehabilitation of blindness; and
- d. Holding academic contests, Braille reading and writing contests and other activities which will highlight the talents and skills of the visually impaired students.

6. All SPED centers, public and private schools with special education programs are encouraged to observe this day with appropriate activities.

A brief consolidated narrative and pictorial report on the celebration shall be submitted to the SPED Division, Bureau of Elementary Education. For further inquiries, please contact Mr. Romeo M.
