

With the help of the Hong Kong Shanghai Banking Corporation Limited, SAS was able to train 99 principals from NCR for the HSBC Principals Leadership Enhancement and Development Program or Principals LEAD Program (PLP) in September 2008 and January 2010. The objective is to develop principals' school based management skills to enable them to transform their schools into innovative learning communities. For school year 2010 – 2011, SAS will once again conduct the Principals LEAD Program (PLP) on January 28, 29 & 30, 2011. We expect a total of 100 principals from our SAS partner schools in NCR and Region III. For this batch, we will be having a selection process.

For your reference, we have attached a copy of DepED Regional Memorandum No. 275; s.2010 entitled HSBC PRINCIPALS LEAD PROGRAM CONFERENCE SY 2010-2011 issued by Dr. Flordeliza R. Magday.

Listed below is a part of the letter our Foundation sent to your Principals; the letter indicates the course of action needed, in order to take advantage of this great opportunity!

- 1. Principals to apply to the HSBC-PLP and attend the HSBC Principals LEAD Program Conference* scheduled for January 28, 29 and 30, 2011. Venue to be announced.
 - *Principals will not be asked to pay any conference expense and will receive <u>partial</u> transportation subsidy.
- 2. Keep in mind that applicant/s must meet the following criteria:
 - During the application process, the principal is from a partner school.
 - Principal should not be a prior beneficiary of the HSBC-PLP.
 - Principal should be a reading advocate.

 Principal has an outstanding record and is recommended by the Schools Division Superintendent and/or District Supervisor.

Applications will be screened and principals who are accepted to the program will be notified through mail.

Please submit ALL completed Application materials on or before <u>SEPTEMBER 15, 2010</u>. Expect to hear back from us on the status on the application by October 15, 2010.

- 3. Principals who are accepted to the HSBC-PLP must commit to:
 - a. Attend the conference from January 28, 29 & 30, 2011.
 - b. Share with other principals and utilize skills and strategies learned during the conference.

To monitor School-Wide Reforms instituted by principals after the conference, Principals LEAD Program Liaison Officers will meet with the principals in their schools:

- School Visit 1- March/April 2011
- School Visit 2 July/August 2011
- 4. A part of the application process is for SUPERVISORS to submit a **SUPERVISORS ASSESSMENT FORM** on behalf of the participant, which should be put in a sealed envelope for confidentiality.

We look forward to your positive response and are confident that you will encourage your principals to seize this unique opportunity to develop their skills in transforming their respective schools into innovate learning communities.
