FURTHER AMENDING EXECUTIVE ORDER NO. 13, S. 2009 (09 SEP 2009) AS AMENDED BY EXECUTIVE ORDER NO. 13-A, S. 2009 IN RELATION TO THE COMPOSITION OF THE 10TH NATIONAL COOPERATIVE SUMMIT QUEZON CITY ORGANIZING COMMITTEE

WHEREAS, Executive Order No, 13, s. 2009, as amended, created the Organizing Committee, its various sub-committees and secretariat for the 10TH National Cooperative Summit to be hosted by and held at Quezon City on 10 October 2010;

whereas, The Organizing Committee immediately commenced preparations for the Summit. Being a cooperative activity, the KEMPCO – a recognized and successful cooperative organization of city government employees, is a member of the 10TH National Cooperative Summit Organizing Committee;

WHEREAS, a change in leadership in the Sangguniang Panlungsod Committee on Cooperatives (05 July 2010) and the KEMPCO Board of Directors (16 March 2010) requires a change in the composition of the 10TH National Cooperative Organizing Committee and Secretariat.

NOW, THEREFORE, I, HERBERT M BAUTISTA, Mayor of Quezon City, by virtue of the powers vested in me by law, do hereby order the amendment of Executive Order Nos. 13, s. 09 and 13-a, s. 09, as follows:
