Resolution No. 01-09

A RESOLUTION PROPOSING AMENDMENTS OF CERTAIN SALIENT PROVISIONS OF THE CONSTITUTION AND BY-LAWS OF THE QUEZON CITY SCHOOLS NON-TEACHING PERSONNEL ASSOCIATION AND ITS RATIFICATION

WHEREAS, The Quezon City Schools Non-teaching Personnel Constitution and By-Laws allows under Article XV thereof the amendment of any of its provisions either by a unanimous vote of its executive board or by 20% of its total membership through a written petition;

WHEREAS, it is has been earlier moved and seconded that certain provisions are no longer applicable or appropriate since they have removed rights and privileges to its members and thus contradicting the objectives of the association;

WHEREAS, it is hereby unanimously resolved that the following provisions of the Constitution and by-laws be amended as follows:

1. Article III, Section 2, par. (d) which reads:

'To participate in major activities such as social, cultural and electoral affairs of the Association, and to attend all meetings and seminars that may be called by the Association or its committees"

is proposed to be amended by deleting the word ALL between the words attend and meetings and which shall hereafter read as follows:

"To participate in major activities such as social, cultural and electoral affairs of the Association, and to attend meetings and seminars that may be called by the Association or its committees"

2. Article III, Section 2, par. (e) sub section "A" which reads

"An employee who meet the basic requirement provided for under the preceding section may become member of the Association upon filing a written application to the Committee on membership and satisfying thereof the necessary membership fee and upon approval of the President upon a favorable recommendation of the Chairman of the Committee on Membership"

is proposed to be amended by the correction of its grammatical tenses which shall hereafter read as follows:

"An employee who meets the basic requirement provided for under the preceding section may become a member of the Association upon the filing of a written application with the Committee on membership and satisfying the necessary membership

fees and thereafter approved by the President upon favorable recommendation of the Chairman of the Committee on Membership"

3. Article III, Section 2, par. (e) subsection "C" (3rd sentence) which reads

'Before the reinstated member may avail of the benefits provided by the Association, he must comply the minimum requirement from the time of his reinstatement'

is proposed to be amended by the correction of its grammatical tenses which shall hereafter read as follows:

"Before the reinstated member may avail of the benefits provided by the Association, he must comply with the minimum requirements as provided under Article III, Section 1 hereof"

4. Article III, Section 2, par. (e) sub section "E" (b), which reads

"Monthly Contributions- in addition, every member is required every month to pay twenty (P20.00) pesos to cover operational expenses, medical assistance fund and death assistance fund (non-refundable)"

is proposed to be amended by the increase in the amount of monthly dues which shall hereafter read as follows:

"Monthly Contributions- in addition, every member is required every month to pay twenty-five (P25.00) pesos to cover operational expenses, medical and death assistance fund which shall be non-refundable"

5. Article III, Section 2, par. (e) sub section "E" (c), which reads

"Monetary Assistance - For compulsory retiring members subject to availability of funds."

is proposed to be amended by the change in the sentence structure which shall hereafter read as follows:

"Monetary Assistance - For compulsory retiring members, monetary assistance may be given upon approval of the majority of the members of the executive board subject to the availability of funds."

6. Article IV, Section 2, which reads:

"Every member has the right to become an officer by a vote of confidence provided that such candidate is a member in good standing, A member in good standing is a member who paid his/her membership fee and who continuously pay his/her monthly dues for at least two (2) years and an active member of the association."

is proposed to be amended by the change in the sentence structure which shall hereafter read as follows:

"Every member is entitled to become an officer through an election by the members provided that such candidate is a member in good standing. A member in good standing is a member who has paid his/her membership fees and who has not defaulted in any of his/her monthly dues for at least two (2) years immediately preceding the elections. A member is considered to be in default of his monthly dues when he/she has failed to pay said dues when they have become due on the particular month required for such payment. However, if the member pays his/her dues in lumpsum, he/she will be considered a member in good standing."

7. Article IV, Section V, which reads:

"Members have the right to participate in policy and decision-making processes insofar as they directly affect their rights, benefits and welfare."

is proposed to be amended by the change in the sentence structure which shall hereafter read as follows:

"Members have the right to participate in policy and decision-making processes insofar as these directly affect their rights, benefits and welfare."

8. Article V, Section 4 has only one representative for Congressional District II and is proposed to be amended by the inclusion of another representative so as to have a representative each for District II-A and District II-B. This amendment is being proposed to divide the representation in the large district to ultimately give greater attention to the non-teaching constituents of the Association.

9. Article VI, section 8, which reads:

"In addition to the foregoing officers of the association, there shall be seven (7) representatives for each congressional district offices $x \times x$."

The seven (7) representatives shall consist of the following $x \times x$.

is proposed to be amended by the change in grammatical infirmity of the provision in order to conform to the amendment on additional representation for District II, which shall thus hereafter read as follows:

"In addition to the foregoing officers of the Association, there shall be eight (8) representatives, one for each congressional district x x x"

The eight (8) representatives shall consist of the following $x \times x$.

Representative for Congressional District II-A

Representative for Congressional District II-B

10. Article VII, Section 1(c), which reads:

'Committee on laws shall be responsible for reviewing this constitution coming up with necessary recommendations. It may propose amendments thereto and shall formulate by-laws, rules and regulations implementing the provisions of this Constitution."

is proposed to be amended by the change in substance of the provision in order to conform to Article XV on Amendments, which shall thus hereafter read as follows:

"Committee on laws shall be responsible for reviewing this constitution coming up with necessary recommendations. It may propose amendments thereto and shall formulate by-laws, rules and regulations implementing the provisions of this Constitution."

11. Article VIII, Section 5, which reads:

'To constitute a quorum, the attendance of at least ten (10) members of the executive board shall be necessary to transact business for the general membership meeting, at least a majority thereof."

is proposed to be amended by the decrease in number of members to constitute a quorum, which shall thus hereafter read as follows:

"To constitute a quorum, the attendance of at least eight (8) members of the executive board shall be necessary to transact business for the association."

RESOLVED THEREFORE, as it is hereby resolved by the members of this Executive Board that the aforementioned proposed amendments be duly approved for ratification by the general assembly in their respective clusters called for such purpose.
