Name of the Supplier”


The markings shall be painted on the following parts of the school furniture:

1. The following are changes in DepED Memorandum No. 292, s. 2009:
 - a. The 3rd Annual General Assembly of the National Organization of Professional Teachers, Inc. (NOPTI) will be held on August 22, 2009 instead of July 18, 2009 in the same venue, Laurels Mansion, Mandaluyong City as stated in said Memorandum.
