Dear Madam,

Under the provision of Dangerous Drugs Act 2002, RA 9165, Article IV, Section 46, concerned Agencies shall establish in its of its provincial offices and cities a **Special Drug Education Center (SDEC) for out-of-school youth and street children in the component cities and municipalities within its geographical coverage**. However, highly urbanized and non-component cities shall be encouraged to establish through their own SDECs to carry out an effective Drug Education Prevention Center. The SDEC maybe establish through any of the following.

a.2. 1) as part of existing facilities of any government organization (GO), non-governmental organization (NGO), civic, labor or religious organization or the private sector.

The **BALIKATAN People's Alliance** is accredited NGO of Philippine Drug Enforcement Agency (PDEA) and a partner of Dangerous Drugs Board (DDB), Philippine National Police (PNP) and Department of social welfare and Development (DSWD). In this connection, we would like to Implement the SPECIAL UNIT or TASK FORCE "Participation of the Family, Students, Communities/ Barangay Officers, Police Officers and NGO's / PO's as School Authorities" in the Enforcement of the Law, Sec. 41-44 of Par. (b) of Article IV, RA 9165, known as Comprehensive Dangerous Drugs Act of 2002.

Moreover, may we request to your good office to disseminate a Memorandum to All Public and Private Elementary and High School Principals / Heads to fill -up the Set - Up of Board Members, SPECIAL UNIT or TASK FORCE for the Compliance of the said provision (Please see attached the Blank Form for submission of two copies for your file and our office file)

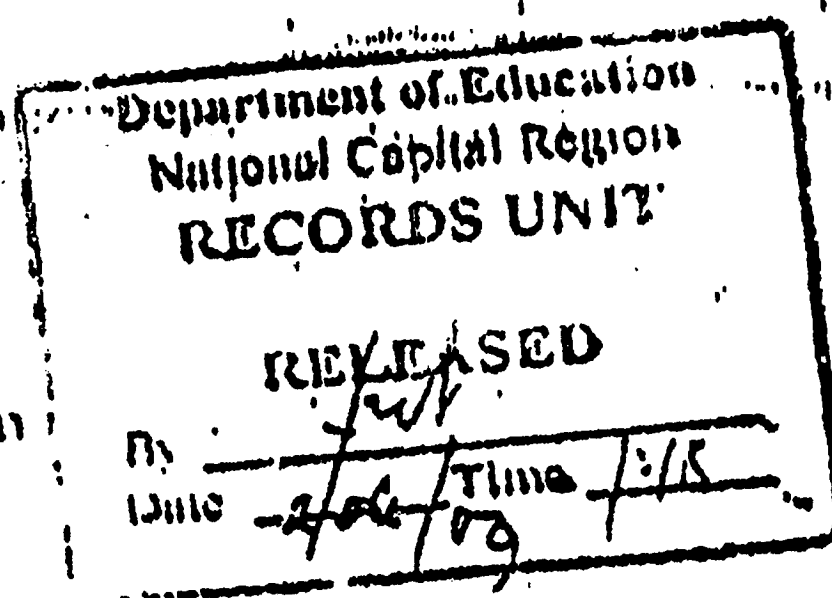

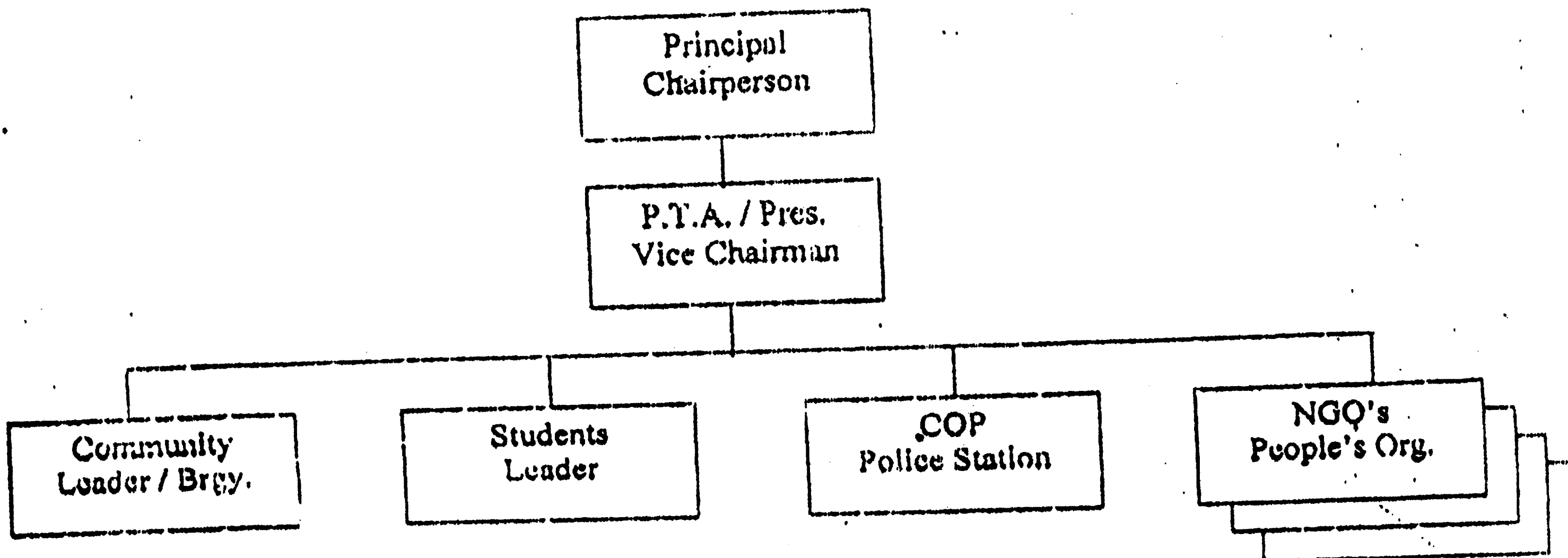
