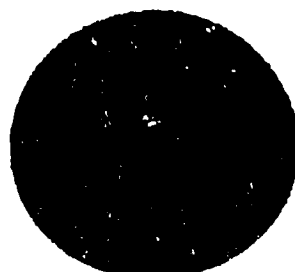

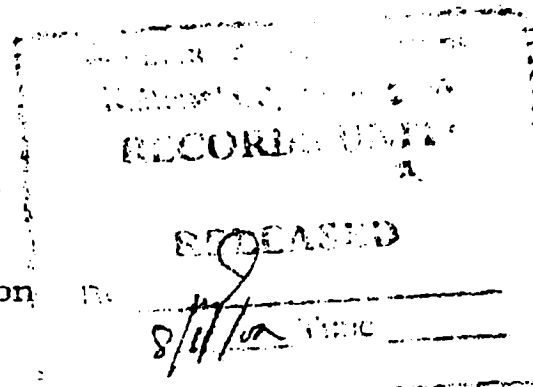

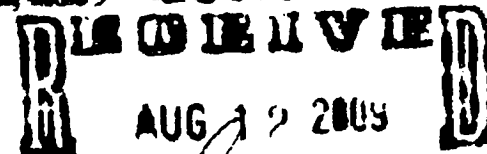

Serra's Center for Girls is a mission center run by the OBLATE SISTERS OF THE MOST HOLY REDEEMER, INC., a private, religious and charitable organization registered with the Securities and Exchange Commission (SEC) with a registration number 121694 and licensed by the Department of Social Welfare and Development (DSWD) with a license number SB-2004-L074 as a non-government child welfare agency. We seek to continuously address the needs of the teenage girls and their families for special protection through the preventive, rehabilitative and protective programs using the caring-teaching-healing model of interventions.

One subcomponent of our programs and services is the ADVOCACY PROGRAM for the prevention of Child Sexual Abuse (CSA) and the other forms of Child Abuse. Our goal is to empower the children, youth and concerned adults in the prevention of CSA. This campaign aims to educate the children and youth on their basic rights and help them gain knowledge and skills on how to protect themselves from possible victimization of abuse. For adult stakeholders, we facilitate a Child Protection Training to seek their support. In addition, we are distributing brochures for providing the participants with information on where to seek help and report cases of abuse.
