



### INTRODUCTION

Photography is one of the forms of art known to man. People young and old alike can express their feelings through the images that they capture with their lenses. Being deaf or having a hearing loss does not alienate them from the opportunity to enjoy the simple yet wonderful blessings that life has to offer. They too are capable of seeing the beauty of things, sometimes even better than the rest of us do.

### **OBJECTIVE**

The photography competition aims to:

- 1. Provide an avenue where the Deaf community can showcase their talents in photography;
- 2. Spread awareness of the Deaf culture; and
- 3. Uphold the advocacy that it is the ability and not the disability that matters

### CONTEST MECHANICS

- 1. The competition is open to all deaf and hard of hearing persons aged 16 years old and above.
- 2. He or she must be a Filipino citizen residing in the Philippines. All members of the Visual Shot Club and hearing people are prohibited to join.
- 3. Entries should be taken within the Philippines only from June 2010 to 2011.
- 4. Entries should be the sole, original and unpublished work of the participant.
- 5. Digital manipulation that distorts the originality of the photos is not allowed. Only basic enhancements such as sharpening, contrast adjustment, converting colored images to black and white is allowed.
- 6. Any images depicting or implying pornographic, slanderous, obscene or vulgar content will automatically be disqualified.
- 7. Each participant can submit 1 application form and a maximum of 5 photos.
  - a. Photos must be in JPEG format, at least 3000 x 2400 pixels with a minimum resolution of 3 megapixels.
  - b. Photo entries may be in colored or monochrome tone.
  - c. Each entry must be accompanied by a title and a short description of not more than 100 words
  - d. All entries must be labeled in the following format. Photos submitted through email must be labeled as well.

- 9. Deadline of entries is on September 30, 2011, Friday at 11:59pm. Photos received after the closing date and time will not be accepted.

### CRITERIA FOR JUDGING

- 1. All entries will be judged according to its originality, creativity and technicality.
- 2. Entries which will not be included in the shortlist will be posted via Facebook for the **People's Choice Award.**
- 3. Winners will be notified through email or text message by the end of October.
- 4. The Judges' decision is final and no inquiries pertaining to the judging and short list process will be entertained during the exhibit.
