Dear Dr. Rubio:

This is to seek your kind attention and coordination regarding practice of some public school teachers / coaches / trainors who bring to Amoranto Sports Complex students / athletes in preparation for the cluster, unit, division, district, region, etc. school meets.

BACKGROUNDER OF PROBLEM:

Some schools do not secure a permit from office which we require to be filed at least one (1) week before signed by the coach and the school principal. Other requirements are:

1. Coach / trainor should be with the students during scheduled practice/s;

2. Letter should include a waiver of liability that the City and Amoranto Sports Complex will not be liable for any loss / damage / injury of the students and further state **who** will be responsible including to other users and property;

3. A statement that the group using the complex should marshal themselves as to cleanliness and maintenance of the complex. Our people lawn the grass and maintain that ground is leveled and safe. Many cases they were left by groups dirty, damaged ground with the use of javelin, discus throw and shot put.

4. We have rehabilitated our comfort rooms but we have experienced that after groups use them, the CRs were dirty, clogged toilet bowls as reported in the past by Broadcaster Ted Failon and some toilet accessories damaged/ missing like floats, flusher, shower head, etc.

5. Some students especially high school students violate the **NO SMOKING** law policy.

The latest we had was the CP Garcia students accompanied by two (2) school teachers without securing a permit in advance.

The Amoranto Sports Complex is everybody's sports center and we had always accommodated schools of its use provided they follow our policy, rules and regulations.
