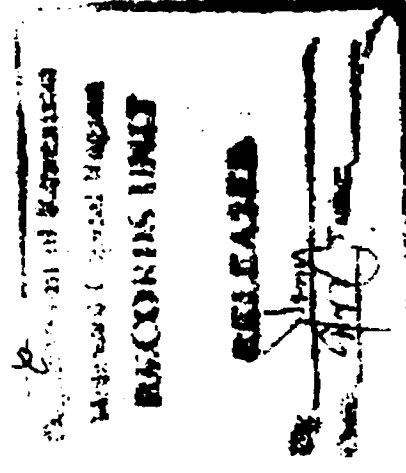
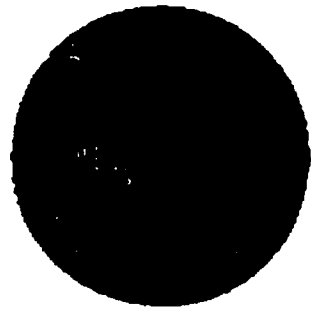

Dear Madam,

Under the provision of Dangerous Drugs Act 2002, RA 9165, Article IV, Section 46, concerned agencies shall establish in each of its provincial offices and cities a Special Drug Education Center for out of school youth and street children in the component cities and municipalities within its geographical coverage. However, highly urbanized and non-component cities shall be encouraged to establish their own SDECs to carry out an effective Drug Education Prevention Center. The SDEC may be established through any of the following manner:

a. 2. 1) as part of existing facilities of any government organization (GO), non-governmental organization (NGO), civic, labor or religious organization or the private sector.

The **BALIKATAN People's Alliance** is accredited NGO of the Philippine Drug Enforcement Agency (PDEA) and partnership of Dangerous Drugs Board (DDB), Philippine National Police (PNP) and Department of Social Welfare and Development (DSWD).

In this connection, we would like to express our gratitude extending the former Director of NCR-DepEd, Dr. Teresita Domalanta to **BALIKATAN** group and we are happy to report to your good office the victory/success of the implementation of Republic Act 9165, Article IV, Section 41-44 known as Dangerous Drugs Act Law 2002, we are able to Create **SPECIAL UNIT** or **TASK FORCE** at Elementary and Secondary Schools in the National Capital Region.

In this regard, may we request to your good office to issue again a **MEMORANDUM** to All Schools Division Superintendent of Public Schools and Presidents/Heads of Private Schools in the National Capital Region for the Capability Enhancement on Drug Education and Implementing Rules & Regulations of the Dangerous Drugs Act Law 2002 of R.A. 9165, particularly the creation of **SPECIAL UNIT** or **TASK FORCE** in every school.
