Based on the ocular inspection conducted by the 1-Team and the Division Review and Evaluation Committee Report and school documents submitted to this Office, the school has complied with the following requirements for the establishment as an Independent School and subsequently naming it to Benigno S. Aguino Jr. Elementary School.

Included in the MOA is the consent to the official separation of Commonwealth Elementary School Annex as independent school in order to absorb the overflow of enrollees of the mother school and the proposed name of the annex school is Benigno Aquino Jr. Elementary School as endorsed by the local government unit and stakeholders
