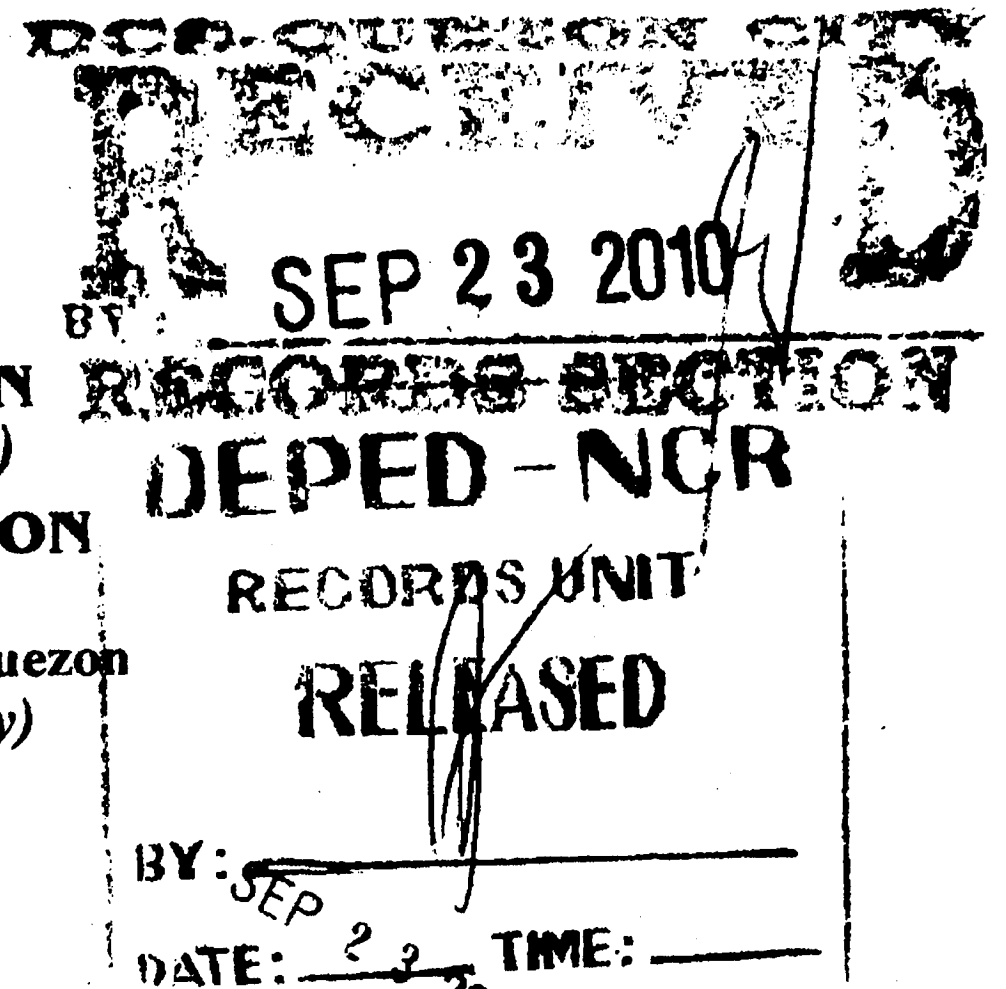
**SUBJECT: DONATION OF CONFISCATED FOREST PRODUCTS BY THE



SUBJECT : Donation of Confiscated Forest Products by the DENR

DATE : 15 September 2010

To help address the shortage of classrooms, desks, tables and other classroom furniture, the Department of Environment and Natural Resources (DENR) is donating confiscated forest products that are without pending court cases to the DepED.

In view of which, all Regional Offices are hereby directed to submit the list of schools with their complete addresses, which are in dire need of these donation. Together with the list of schools, the following documents must also be submitted:

- a. Justification for the construction of the classroom furniture, signed by the School Principal and duly endorsed by the Division Superintendent; and
- b. Bill of materials and building plan duly approved by the project engineer.

Based on the schools' requirements, DENR through its CENRO shall then provide a certification that the type and volume of forest product needed for the construction of these classroom furniture is available.

Attached herewith is the draft of the Deed of Donation to be executed by the DENR Regional Executive Director and DepED Regional Director concerned, for your perusal.

Finally, you may coordinate with the Unified Command of the Armed Forces of the Philippines which will provide transportation assistance, per attached letter of Bng. Gen. Nonato Alfredo T. Peralta, Jr.


Dear **Acting Secretary Paje**:

KNOW ALL MEN BY THESE PRESENTS:

This Deed of Donation executed by the Department of Environment and Natural Resources, Region _____, represented by its Regional Executive Director, _____ hereinafter called the **DONOR**, in favor of the Department of Education, Region _____ as represented by its Regional Director, _____ hereinafter called the **DONEE**.

That the **DONOR** has confiscated forest products as enumerated and described as follows:

That the **DONOR** hereby donates the aforesaid forest products free from all liens and encumbrances to the **DONEE** by virtue of the Memorandum of DENR Secretary dated July 16, 2010 instructing the turn-over / donation of all confiscated forest products without court cases to the Department of Education, conformably with the following terms and conditions:

1. That the **DONEE** shall utilize the donated volume of the lumber/fitches/logs for the construction of various public school buildings, and/or the manufacture of office fixtures, desks, tables, etc.
2. That the **DONEE** shall be responsible in the hauling, distribution, documentation of the donated forest products from the custodian or place stockpiled to the different projects of the Department of Education, with representatives from the concerned COA and Provincial Accountant offices.
3. That upon completion of any Department of Education project, a certificate of completion signed by the Project Engineer, supported with photographs and an itemization of forest products used in the project, shall be submitted by the **DONEE** to the **DONOR**.

That the **DONEE** does hereby accept this donation of the above described forest products.
