SUBJECT : NATIONAL FLAG AT HALF MAST

As the nation mourns the passing of the late **Honorable Jesse M. Robredo**, Secretary, Department of the Interior and Local Government, all City Government, including Barangay facilities, installations and buildings with flag staff are directed to immediately fly the National Flag at half mast.

The flying of the National Flag at half mast shall be in keeping with the provisions of Section 27©, Rule III of the Rules and Regulations Implementing Republic Act 8491:

"Cabinet Secretaries, Associate Justices of the Supreme Court, Members of the Senate and House of Representatives, the Chief of Staff of the Armed Forces of the Philippines, and the director General of the Philippine National Police, or equivalent in rank, for **Five (5) Days;**"

In view of the above provision, all schools under this Division are directed to immediately fly the National Flag at half mast.

Immediate and wide dissemination of this Memorandum is desired.

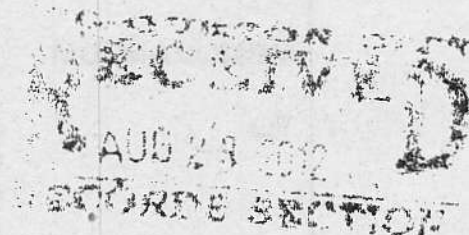
