This change of date has already been announced and agreed upon by the officers and members of the Elementary School Papers Advisers Council during their last meeting.

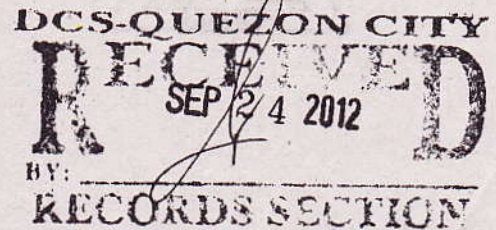
In the light of the above, may we, respectfully request that a corrigendum to Division Memorandum No. 240- S - 2012 be issued to this effect the soonest possible time..
